**RESOLUTION**

**Declaring LCRB and Recommending Award  
Procurement of Male Condom for STI/HIV Prevention (Supply for Social Hygiene  
Clinics and Other Health Facilities)  
For the Department of Health – Central Office (DOH-CO)  
Bid Ref. No. GPG-B1-2017-054**

WHEREAS, on 24 February 2017, PITC caused the advertisement of the Invitation to Bid of the public bidding for the procurement project entitled **Procurement of Male Condom for STI/HIV Prevention (Supply for Social Welfare Clinics and other Health Facilities) for the Department of Health – Central Office (DOH-CO) under Bid Ref. GPG-B1-2017-054** in the *Philippine Star*, and postings in the PhilGEPS, PITC Website, and in conspicuous place within the premises of its office continuously for seven (7) calendar days, as follows:

WHEREAS, on 14 March 2017, PITC caused the advertisement of an Amended Invitation to Bid for the said procurement project in the *Philippine Star*, and postings in the PhilGEPS, PITC Website and in conspicuous place within the premises of its office continuously for seven (7) calendar days;

WHEREAS, in response to the aforesaid advertisement and postings, six (6) prospective Bidders purchased Bidding Documents for the subject item, namely:

1. G-Well General Merchandise (hereinafter "**G-Well**");
2. Pharmaceutica Filipina de Visayas (hereinafter "**Pharmaceutica**");
3. AAA Pharma Inc. (hereinafter "**AAA Pharma**");
4. Phil Pharmawealth, Inc. (hereinafter "**Phil Pharmawealth**");
5. I.E. Medica Inc. (hereinafter "**I.E. Medica**"); and
6. Thai Nippon Rubber Industry Public Co Ltd/Ulife Corp. (hereinafter "**Thai/Ulife**").

WHEREAS, on the date of submission and opening of bids on 17 April 2017, only **AAA Pharma, Phil Pharmawealth, I.E. Medica, and Thai/Ulife** submitted their Eligibility and Technical Documents and their Financial Bids for the subject item;

WHEREAS, on the said bid opening date, this Committee proceeded to open the Eligibility and Technical documents of **AAA Pharma** and declared **AAA Pharma's** eligibility and technical submittals as "**Passed**";



**WHEREAS**, on the said bid opening date, this Committee proceeded to open the Eligibility and Technical documents of **Phil Pharmawealth** and declared **Phil Pharmawealth's** eligibility and technical submittals as **"Passed"**;

**WHEREAS**, on the said bid opening date, this Committee proceeded to open the Eligibility and Technical documents of **I.E. Medica** and declared **I.E. Medica's** eligibility and technical submittals as **"Passed"**;

**WHEREAS**, on the said bid opening date, this Committee proceeded to open the Eligibility and Technical documents of **Thai/Uiife** and declared **Thai/Uiife's** eligibility and technical submittals as **"Failed"** for the following reasons:

1. No Tax Clearance submitted; and
2. No evidence of payment or Final Acceptance for the Single Largest Completed Contract.

Thus, the Committee no longer proceeded to open the Financial Bid of **Thai/Uiife**.

**WHEREAS**, having passed the eligibility and technical checking, this Committee proceeded to open the financial bid of **AAA Pharma, Phil Pharmawealth** and **I.E. Medica Inc.** the result of which are as follows:

**WHEREAS**, no Motion for Reconsideration was filed by **Thai/Uiife** with this Committee within the period prescribed therefor;

**WHEREAS**, on 24 April 2017, after conducting a bid evaluation, this Committee issued to **I.E. Medica Inc.** the Notice of Lowest Calculated Bid for the subject item;

**WHEREAS**, pursuant to the Post-Qualification procedures under the Revised IRR of RA 9184 and after careful examination, validation and verification of the eligibility, technical and financial requirements on post-qualification, the bid submitted by **I.E. MEDICA, INC.** was found to be the **LOWEST CALCULATED AND RESPONSIVE BID** for the subject item as shown by the corresponding **Notice of Post Qualification**, a copy of which is hereto attached as **Annex "B"** and made an integral part hereof;

**NOW, THEREFORE**, for and in consideration of the foregoing, **We**, the Members of the Bids and Awards Committee I, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **I.E. MEDICA INC.** as the bidder with the **Lowest Calculated and Responsive Bid** for the subject item;
- b) To recommend award of the Contract to **I.E. MEDICA INC.** for the procurement project entitled **Procurement of Male Condom for STI/HIV Prevention (Supply for Social Welfare Clinics and other Health Facilities) for the Department of Health – Central Office (DOH-CO) under Bid Ref. GPG-B1-2017-054;** and
- c) To recommend the foregoing findings for approval of the PITC President.
