



**INVITATION TO BID**

**SUPPLY AND DELIVERY OF 111 SETS BRAND NEW TRACTOR WITH COMPATIBLE SUGARCANE WHOLE-STALK CUTTER FOR THE SUGAR REGULATORY ADMINISTRATION (SRA)**

1. The **Philippine International Trading Corporation (PITC)** and the **Sugar Regulatory Administration (SRA)** intend to apply the sum of **Pesos: One Hundred Sixty One Million Eighty Seven Thousand Four Hundred Sixty One & 29/100(₱ 161,087,461.29)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **Supply and Delivery of 111 Sets Brand New Tractor with Tractor Sugarcane Whole-stalk Cutter for the Sugar Regulatory Administration (SRA).**

2. PITC and SRA now invite bids from manufacturers or authorized local distributors, dealers, resellers for the Supply and Delivery of 111 sets Brand New Tractor with Compatible Sugarcane Whole-stalk Cutter (hereafter referred to as GOODS).
3. **Project Completion Period and Delivery Site:**

4. A prospective bidder should have completed within the last five (5) years from the date of submission and receipt of bids equivalent to:
  - At least one (1) single contract of similar nature amounting to at least fifty percent (50%) of the ABC of the item being bid for; OR
  - Two (2) or more contracts of similar nature equivalent to at least fifty percent (50%) of the ABC for the project the largest of these contracts must be equivalent to at least twenty five percent (25%) of the ABC of the lot being bid for.

“**Similar**” contract shall refer to contracts pertaining to **farm machineries and/or implements**.

5. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
6. The complete set of Bidding Documents may be acquired by interested bidders from Monday to Friday between 9:00AM to 2:00PM upon payment of a non-refundable fee as indicated above and look for the following BAC Secretariat. **However, bidders who previously bought bidding documents for Bid Reference No. GPG-B1-2019-205 and GPG-B1-2019-428 Rebid may acquire the Bidding Documents free of charge upon presentation of official receipt.**
