Below is the query/request for consideration by AREZA MOTOR SALES in its letter/e-mail and received by BAC dated 08 June 2018, which have been answered by the **PITC Bids and Awards Committee I and Philippine Army:**

Query 1:	During the pre-bid conference, the term brand new was never discussed. We seek clarification as whether the term brand new refers to 2018 models of SUV or does brand new refer to manufactured vehicles regardless of the year and model as long as the said vehicle were never sold in the market.
PITC/PA Response:	Brand New means <u>latest model</u> and not second hand or re-conditioned.
Query 2:	We would like to seek clarification as to the requirement of the displacement. On the technical specification it states that the minimum displacement is between 2,100 to 2,400cc. For a 4-cylinder, 16 Valve Engine the minimum displacement is 2,000cc. Finally, by lowering the requirement to 2,000cc minimum is to allow a better fuel efficiency with the same results as 2,400cc displacement.
PITC/PA Response:	REQUEST DENIED Displacement remains at "between 2,100 to 2,400cc"
