1. The **Philippine International Trading Corporation (PITC)** intends to apply the sum of Pesos: Four Million Six Hundred Thirty Thousand Two Hundred & 00/100 Only (₱4,630,200.00) being the Approved Budget for the Contract (ABC) to payment under the contract for the **Procurement of PITC Janitorial and Allied Services Requirement for Three (3) Years**.

2. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
3. PITC now invites Bids from JANITORIAL AND ALLIED SERVICES AGENCIES for the PITC Janitorial and Services Requirement for Three (3) Years (hereafter referred to as "GOODS").
4. The bidding is restricted to Filipino citizens / sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. A prospective Bidder must have completed a single largest contract of similar nature within last five (5) years amounting to at least fifty percent (50%) of the total ABC.

Similar contract shall mean "Janitorial or Manpower Services".

6. Open competitive bidding procedures will be conducted using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its **2016** Revised IRR.

7. The Invitation to Bid and Bidding Documents may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and PITC website at www.pitc.gov.ph. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
8. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am – 4:00pm) but not later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

However, bidders who previously bought bidding documents for Bid Ref. No. ASD-B1-2019-155 may acquire the bidding documents free-of-charge upon presentation of official receipt.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
