1. The **Philippine International Trading Corporation (PITC)** intends to apply the sum of the following being the **Approved Budget for the Contract (ABC)** to payment under the contract for the **Procurement of PITC Security Services Requirement for Three (3) Years**, more particularly described as follows:

2. Bids received in excess of the ABC shall be automatically rejected at Bid opening.  
 3. PITC now invites Bids from SEC-Registered Security Agencies, for the PITC SECURITY SERVICES REQUIREMENT FOR THREE (3) YEARS (hereafter referred to as "GOODS").

The Security Agency must be a member of the Philippine Association of Detective and Protective Agency Operators, Inc. (PADPAO) or other organizations recognized by the Philippine National Police-Supervisory Office for Security and Investigation Agencies (PNP-SOSIA) per Section 9.2 (a) of DOLE Department Order No. 150-16.

5. The bidding is open to Filipino citizens/ sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

6. A prospective Bidder should have completed a single contract similar to the contract to be bid amounting to at least fifty percent (50%) of the ABC of the project within the last five (5) years from the date of submission and receipt of bids.

*Similar contract shall mean “Security Services”.*

7. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its 2016 Revised IRR.
8. The Invitation to Bid and Bidding Documents may be downloaded from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and **PITC website at [www.pitc.gov.ph](http://www.pitc.gov.ph)**. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
9. The complete set of Bidding Documents maybe acquired by interested bidders during office hours (8:00am – 4:00pm) but no later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective bidder or his duly authorized representative upon presentation of proper identification document.

However, bidders who previously bought bidding documents for Bid Reference No. ASD-B1-2019-154 may acquire the bidding documents free-of-charge upon presentation of official receipt.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the bid documents.
