



## INVITATION TO BID

### SUPPLY AND DELIVERY OF 126 UNITS BRAND NEW 1,000 GALLONS CAPACITY FIRE TRUCKS FOR THE BUREAU OF FIRE PROTECTION NATIONAL HEADQUARTERS (BFP-NHQ)

Approved Budget for the Contract: ₱ 1,881,473,992.02

1. The **Philippine International Trading Corporation (PITC)** and the **Bureau of Fire Protection National Headquarters (BFP-NHQ)** intend to apply the sum of **Pesos: One Billion Eight Hundred Eighty One Million Four Hundred Seventy Three Thousand Nine Hundred Ninety Two & 02/100 (₱ 1,881,473,992.02)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **Supply and Delivery of 126 Units Brand New 1,000 Gallons Capacity Fire Trucks for the Bureau of Fire Protection National Headquarters (BFP-NHQ)**. Bids received in excess of the ABC shall automatically be rejected at Bid opening.

\* The Cashier's/Manager's Check shall be issued by a Local Universal or Commercial Bank.

\*\* The Bank Draft/Guarantee or Irrevocable Letter of Credit shall be issued by a Local Universal or Local Commercial Bank.

2. **PITC** and **BFP-NHQ** now invite bids from Manufacturers or First Tier Distributors for the Supply and Delivery of 126 Units Brand New 1,000 Gallons Fire Trucks for the Bureau of Fire Protection National Headquarters (BFP-NHQ) (hereafter referred to as GOODS).
- “First Tier Distributor”** shall mean a Philippine-based company directly appointed by the principal manufacturer of the item/equipment.
3. The bidding is open to local and foreign Manufacturers or Local First Tier Distributors. However, foreign manufacturers must be represented by a Philippine based company.
4. A prospective Bidder should have completed within the last **ten (10) years** from the date of submission and receipt of bids:
- At least one (1) single contract of similar nature amounting to at least fifty percent (50%) of the ABC, or;
  - Aggregate of multiple contracts of similar nature and the aggregate contract amounts must at least be equivalent to fifty percent (50%) of the ABC, the largest of which must be atleast equivalent to twenty five percent (25%) of the ABC of the project.



“**Similar contract**” shall refer to the supply and delivery of fire trucks, aerial ladder, aerial tower, break squirt fire truck, rescue tender and rescue truck and vehicle.

5. **Project Completion Period:**

**Delivery Place:** National Fire Training Institute (NFTI), Camp Vicente Lim, Calamba, Laguna

**However, if payment is through a Letter of Credit, the supplier’s Proforma Invoice for LC opening must be issued/made to PITC within seven (7) calendar days from receipt of Notice of Award. Also, Single Administrative Document (SAD) must be submitted within seven (7) calendar days upon receipt of the Notice to Submit SAD. Otherwise, the period for delivery shall be reckoned from date of receipt of the Notice to Proceed.**

- Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its 2016 Revised IRR.
- The Invitation to Bid and Bidding Documents may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and PITC website at [www.pitc.gov.ph](http://www.pitc.gov.ph). Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
- The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am – 4:00pm) but not later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
