



INVITATION TO BID

SUPPLY AND DELIVERY OF ONE (1) UNIT BRAND NEW AMPHIBIOUS VEHICLE FOR THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD)

1. The **Philippine International Trading Corporation (PITC)** and the **Department of Social Welfare and Development (DSWD)** intends to apply the sum of **Pesos: Fifteen Million Ninety Thousand Six Hundred Ninety Eight & 57/100 only (P 15,090,698.57)** being the Approved Budget for the Contract (ABC) to payment under the contract for the Supply and Delivery of One (1) Unit Brand New Amphibious Vehicle for the Department of Social Welfare and Development (DSWD). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. **PITC** and **DSWD** now invite bids from authorized Philippine Automotive Dealers/Suppliers/ Distributors for the Supply and Delivery of One (1) Unit Brand New Amphibious Vehicle (hereafter referred to as GOODS).
3. The bidding is open to Filipino citizens / sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. A prospective Bidder should have completed a contract of similar nature within the **last five (5) years** from the date of submission and receipt of bids amounting to at least **fifty percent (50%)** of the ABC of the item being bid for.
“Similar contract” shall mean Cargo Amphibious Vehicle.
The brand of the Amphibious vehicle must have been in the Philippine Market for the last **five (5) years**.
5. **Delivery Period:** Within sixty (60) calendar days after receipt of Notice to Proceed.
Delivery Place: DSWD NROC, NAIA, Chapel Road, Pasay City
6. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016 Revised IRR**.



7. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the **PhilGEPS** and the **PITC** website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents.
