



INVITATION TO BID

SUPPLY, DELIVERY, TESTING AND COMMISSIONING OF MOBILE VEHICLE INSPECTION FACILITY (MVIF) (CONTAINERIZED AND TRUCK MOUNTED) FOR THE DEPARTMENT OF TRANSPORTATION (DOTr)

1. The **Philippine International Trading Corporation (PITC)** and the **Department of Transportation (DOTr)** intend to apply the sum of **PESOS: Seven Hundred One Million Four Hundred Ninety Eight Thousand Twenty One & 90/100 (₱ 701,498,021.90)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **Supply, Delivery, Testing, and Commissioning of Mobile Vehicle Inspection Facility (MVIF) (Containerized and Truck Mounted) for the Department of Transportation (DOTr)**. Bids received in excess of the ABC shall be automatically rejected at bid opening:

2. **PITC** and **DOTr** now invite bids from eligible Manufacturers of Vehicle Inspection Facility with authorized nationwide service centers (hereafter referred to as GOODS).
3. The bidding is open to authorized local and foreign manufacturers. However, foreign manufacturers must be represented by a Philippine based company who must have nationwide after-sales service centers.
4. The manufacturer must have been in the business of manufacturing Vehicle Inspection Equipment for the past ten (10) years.

6. A prospective Bidder should have completed within the last five (5) years from the date of submission and receipt of bids at least a single contract similar to the contract to be bid amounting to at least **fifty percent (50%)** of the ABC of the project

“Similar” contract shall refer to contracts for the supply and delivery of Vehicle Inspection Equipment.

7. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
8. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above.

The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
