- The **Philippine International Trading Corporation (PITC)** and the **Department of Health (DOH)** intend to apply the sum of **PESOS: Two Hundred Seventy Three Million and 00/100 (₱ 273,000,000.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **Supply, Delivery, Installation and Commissioning of One Hundred Forty (140) Units Brand New Hemodialysis Equipment with Various Accessories and Consumable Medical Devices for the Department of Health (DOH)**

Bids received in excess of the ABC shall be automatically rejected at Bid opening.

- PITC and DOH now invite bids from Local or Foreign Manufacturers or Local First Tier Distributors of the principal manufacturer for the Supply, Delivery, Installation and Commissioning of One Hundred Forty (140) Units Brand New Hemodialysis Equipment with Various Accessories and Consumable Medical Devices (hereafter referred to as GOODS).

*"First Tier Distributor" shall mean a Philippine company directly appointed by the principal manufacturer of the equipment with ongoing business relationship over the last five (5) years, regardless of the type of equipment/products carried for the principal manufacturer.*

Foreign Manufacturers must be represented by a Philippine-based company.

- A prospective Bidder must have completed a Single contract of similar nature within the last five (5) years amounting to at least fifty percent (50%) of the ABC of the item being bid.

Similar contract shall mean "**Medical Equipment**".

- The **Delivery of GOODS** shall be within One Hundred Twenty (120) calendar days upon receipt of Notice of Site Readiness and Possession.

**Delivery Place:** On-site per DOH List of Recipients (Reference: **Annex V-A2** of the Bidding Documents)

5. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
6. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
