



## INVITATION TO BID

### SUPPLY, DELIVERY, TESTING AND COMMISSIONING OF ONE (1) SET BRAND NEW ELISA READER AND ELISA WASHER FOR THE UNIVERSITY OF THE PHILIPPINES-MANILA – PHILIPPINE GENERAL HOSPITAL (UPM-PGH)

1. The **Philippine International Trading Corporation (PITC)** and the **University of the Philippines-Manila – Philippine General Hospital (UPM-PGH)** intend to apply the sum of the following being the Approved Budget for the Contract (ABC) to payment under the contract for the corresponding item. Bids received in excess of the ABC for each lot/item shall be automatically rejected at bid opening.

2. PITC and UPM-PGH now invite bids from Suppliers who are themselves Manufacturers or First Tier Distributors of the principal manufacturer for the Supply, Delivery, Testing and Commissioning of One (1) Set Brand New Elisa Reader & Elisa Washer with Accessories for the University of the Philippines-Manila (UPM) – Philippine General Hospital (PGH) (hereafter referred to as GOODS).

*“First Tier Distributor” shall mean a company directly appointed by the principal manufacturer of the equipment with ongoing business relationship with at least three (3) years, regardless of the type of equipment/products carried for the principal manufacturer.*

3. The bidding is open to Filipino citizens/sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. The Project Completion/Delivery Period: Within One Hundred Twenty (120) calendar days after receipt of Notice to Proceed or Opening of Letter of Credit whichever comes later. However, if payment is through a Letter of Credit, the supplier's Proforma Invoice for LC opening must be issued/made to PITC within seven (7) calendar days from receipt of Notice of Award. Also, Single Administrative Document (SAD) must be submitted within seven (7) calendar days upon receipt of the Notice to Submit SAD. Otherwise, the period for delivery shall be reckoned from date of receipt of the Notice to Proceed.

5. A Bidder must have completed a Single contract of similar nature within last five (5) years amounting to at least fifty percent (50%) of the ABC of the item being bid.

*Similar contract shall mean “Laboratory/Medical Equipment”*

6. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
7. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
