Query	We would like to ask the following question on the Technical Specifications: 1.) It states that "All components should be compatible with the Universal Laser System Laser Cutter model VLS 3.6". Thus, this mean that UNIVERSAL LASER SYSTEM is the ONLY brand you will be accepting? How about other brand of CNC Laser Cutter which also complies with the technical specs?
Reply	<i>Request denied. CHED-PCARI is procuring Laser Cartridge and Peripherals for an existing laser system, ULS VLS 3.60, not a new laser cutter. That is why brand and model is specified.</i> <i>Bidders may offer other brands but it must be compatible and should work on our existing laser system for compliance/acceptance. They must show proof that their offers will be compatible/usable with ULS VLS 3.60.</i>
