1. The **Philippine International Trading Corporation (PITC)** and the **Philippine National Police (PNP)** intend to apply the sum of **PESOS: One Hundred Fifty Seven Million Six Hundred Eighty One Thousand Nine Hundred Fifty Seven and 17/100 (₱ 157,681,957.17)** being the Approved Budget for the Contract (ABC) to payment under the contract for the Supply and Delivery of One (1) Lot Brand New Light Machine Guns consisting of 141 Units Brand New Caliber 7.62mm and 8 Units Brand New Caliber 5.56mm for the Philippine National Police (PNP).

Bids received in excess of the ABC shall be automatically rejected at Bid opening. Late bids shall not be accepted.

2. **PITC** and **PNP** now invite bids from authorized Manufacturers or First Tier Distributors for the Supply and Delivery of One (1) Lot Brand New Light Machine Gun Consisting of 141 Units Brand New Light Machine Gun Caliber 7.62mm and 8 Units Brand New Light Machine Gun Caliber 5.56mm for the Philippine National Police (PNP) (hereafter referred to as GOODS).



“First Tier Distributor” shall mean a Philippine-based company directly appointed by the principal manufacturer of the item who has been engaged in the sale of firearms for a cumulative period of five (5) years and with a valid and current Indentor’s License to deal in firearms for sale to the Armed Forces of the Philippines / Philippine National Police (AFP/PNP).

However, Foreign Manufacturers must be represented by a reputable Philippine based Company who has been engaged in the sale of firearms for a cumulative period of five (5) years and with a valid and current Indentor’s License to deal in firearms for sale to the Armed Forces of the Philippines / Philippine National Police (AFP/PNP).

3. Required delivery period and delivery place shall be as follows:

However, if payment is through a Letter of Credit, the supplier’s Proforma Invoice for LC opening must be issued/made to PITC within seven (7) calendar days from receipt of Notice of Award. Also, Single Administrative Document (SAD) must be submitted within seven (7) calendar days upon receipt of the Notice to Submit SAD. Otherwise, the period for delivery shall be reckoned from date of receipt of the Notice to Proceed.

4. A prospective Bidder must have a single (1) largest completed contract similar to the contract to be bid within the last five (5) years from date of submission and receipt of bids amounting to at least fifty per cent (50%) of the ABC of the project.

“Similar” contract shall mean Firearms.

5. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016 Revised IRR**.
6. The Invitation to Bid and Bidding Documents may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and PITC website at www.pitc.gov.ph.
7. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
