Query	<p><i>This is in reference to Public Bidding No. GPG-B1-2018-372: Supply and Delivery of 1,677 Units Brand New Basic Assault Rifle 5.56 mm for the Philippine National Police.</i></p> <p><i>One of the requirements for eligibility and technical documents is the “Certificate of Performance Evaluation” which needs to be signed by the bidder’s customer for the Statement of Single Largest Contract.</i></p> <p><i>For your information, our foreign joint venture partner, will not be able to ask this evaluation report from their customer, which is a major armed forces, to sign the said document. But so far, our joint venture partner has already delivered 1,000,000 units of rifles to this foreign armed forces which we can reveal during the Submission and Opening of Bids.</i></p> <p><i>In this regard, we would like to request your good office to please kindly consider “waiving” this evaluation certificate and instead, accept an equivalent document to prove that this foreign armed forces has accepted our partner’s delivery in “good order and condition” and have not complained of the quality thereof.</i></p>
Reply	<p>Request denied. PNP as the end-user, maintained the said requirement for the Certificate of Performance Evaluation (Annex VI) from the Single Largest Completed Contract as declared in Annex I-A.</p>
