Bids received in excess of the ABC shall be automatically rejected at bid opening.

- PITC and PNP now invite bids from authorized local First Tier distributor for the Supply and Delivery of 22 Units Portable Communication System Integrators for the Philippine National Police (PNP) (hereafter referred to as GOODS).

“First Tier Distributor” shall mean a Philippine company directly appointed by the principal manufacturer of the equipment with ongoing business relationship regardless of the type of equipment/products carried for the principal manufacturer.

- A prospective Bidder must have completed a Single contract of similar nature within the last five (5) years amounting to at least fifty percent (50%) of the ABC of the item being bid.

Similar contract shall mean **“Communication Equipment”**.

- The **Delivery of GOODS** shall be within One Hundred Twenty (120) calendar days upon receipt of Notice to Proceed.

Delivery Sites: On site per PNP designated sites (Reference: **Annex V-A2** of the bidding documents)

- Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of

Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.

6. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
