



INVITATION TO BID

SUPPLY, DELIVERY AND INSTALLATION OF NETWORK CONNECTIVITY (INTERNATIONAL PRIVATE LINE TO USA) FOR THE ADVANCED SCIENCE AND TECHNOLOGY INSTITUTE (ASTI)

1. The **Philippine International Trading Corporation (PITC)** and the **Advanced Science and Technology Institute (ASTI)** intend to apply the sum of **PESOS: One Hundred Fourteen Million Thirty Six Thousand Seventy Two & 00/100 (₱ 114,036,072.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **Supply, Delivery and Installation of Network Connectivity (International Private Line to USA) for the Advanced Science and Technology Institute (ASTI)**. Bids received in excess of the ABC shall be automatically rejected at bid opening:

2. **PITC** and **ASTI** now invite bids from eligible Information and Communications Technology Contractors / Telecommunication Providers / Service Integrators / Value Added Service Provider / Internet Service Provider for the Supply, Delivery and Installation of Network Connectivity (International Private Line to USA) (hereafter referred to as GOODS).
3. The bidding is open to authorized local and foreign telecommunication companies. However, foreign Bidders must be represented by a Philippine based company.



4. Project Contract Period / Project Site:

5. A prospective Bidder should have completed within the last five (5) years from the date of submission and receipt of bids at least a single contract similar to the contract to be bid amounting to at least **twenty five percent (25%)** of the ABC of the project.

“Similar” contract shall refer to contracts for Internet Services.

6. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
7. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above.

The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
