SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF NINE (9) LOTS SOLID WASTE MANAGEMENT EQUIPMENT CONSISTING OF BRAND NEW MULTI- PURPOSE WASTE SHREDDER AND BRAND NEW COMPOSTER FOR THE DENR-EMB TO SUPPORT LOCAL GOVERNMENT UNITS (LGUs) IN THE MANILA BAY REGION AND OTHER SELECTED LGUs

Bids received in excess of the ABC for each Lot shall be automatically rejected at Bid opening.

2. The PITC and DENR-EMB now invite Bids from authorized Philippine Fabricators/Manufacturers/Distributors who have been in the fabricating business for the last five (5) years for the Supply, Delivery, Installation, Testing and Commissioning of Nine (9) Lots Solid Waste Management Equipment consisting of Brand New Multi-Purpose Waste Shredder and Brand New Composter for the DENR-EMB to Support Local Government Units (LGUs) in the Manila Bay Region and Other Selected LGUs (hereinafter referred to as **GOODS**).
3. The bidding is restricted to Filipino citizens / sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging citizens of the Philippines.
4. A prospective Bidder should have completed a contract of similar nature within the **last five (5) years** from the date of submission and receipt of bids amounting to at least **fifty percent (50%)** of the ABC of the lot being bid.

Similar contract shall mean “**Industrial Equipment**”.

5. The **Delivery, Installation, Testing and Commissioning** shall be within **One Hundred Twenty (120)** calendar days after receipt of Notice to Proceed or Opening of Letter of Credit whichever comes later.
6. **Delivery and Installation Sites:** Please refer to the DENR-EMB Delivery and Installation Sites per **Annex V-M**.
7. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
8. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

Note: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
