



**INVITATION TO BID**

1. The Philippine International Trading Corporation (PITC) and the Bureau of Customs intend to apply the sum of Pesos: **Fifty-Eight Million Forty-Nine Thousand Five Hundred Thirty-Five Pesos and 60/100 (P 58,049,535.60)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **Supply, Delivery, Installation, Testing, Configuration and Migration of Co-Location Backup Services for the Bureau of Customs.**

2. PITC and BOC now invite bids from authorized Philippine ICT Solutions and/or Service Providers for the Supply, Delivery, Installation, Testing, Configuration and Migration of Co-Location Backup Services for the Bureau of Customs. (hereafter referred to as GOODS).
3. Delivery, Installation, Testing, Configuration and Migration.

4. Prospective bidders must be in the business for **at least ten (10) years** and must have completed a contract of similar nature within last five (5) years from the date of submission and receipt of bids as follows:
  - a. Single completed contract of similar nature within the last five (5) years equivalent to at least fifty percent (50%) of the ABC

**OR**

  - b. At least two (2) completed contracts of similar nature within the last five (5) years from the date of submission and receipt of bids and the aggregate contract amounts should be equivalent to at least fifty percent (50%) of the ABC. The largest of these similar contracts must be equivalent to at least twenty-five percent (25%) of the ABC

**Similar contract shall mean “Database Software and Migration Services for Critical Database System”.**

5. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

6. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

7. Interested bidders may obtain further information from PITC and inspect the Bidding Documents at the address given below during office hours.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
