

## INVITATION TO BID

### PROCUREMENT OF SUBSCRIPTION OF PHARMACEUTICAL MARKET DATA FROM DRUGSTORES AND HOSPITALS (3-YEAR DATA) AND PHARMACEUTICAL SALES FROM INTERNATIONAL MARKET WITH PHILIPPINE DATA (2018-2020) FOR THE DEPARTMENT OF HEALTH (DOH)

1. The **Philippine International Trading Corporation (PITC)** and the **Department of Health (DOH)** intend to apply the sum of **PESOS: Twelve Million** being the Approved Budget for the Contract (ABC) to payment under the contract for the **Procurement of Subscription of Pharmaceutical Market Data from Drugstores and Hospitals (3-year data) and Pharmaceutical Sales from International Market with Philippine Data (2018-2020) for the Department of Health (DOH)**

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. PITC and DOH now invite bids from Suppliers who are themselves Data Provider for the Procurement of Subscription of Pharmaceutical Market Data from Drugstores and Hospitals (3-year data) and Pharmaceutical Sales from International Market with Philippine Data (2018-2020) for the Department of Health (DOH) (hereafter referred to as GOODS).
3. A prospective Bidder must have completed a Single contract of similar nature within last five (5) years amounting to at least fifty percent (50%) of the ABC of the item being bid.

**Similar contract shall mean "Subscription to web-based Pharmaceutical Sales Data".**

4. The **Delivery of GOODS** shall be within sixty (60) calendar days after receipt of Notice to Proceed.

Delivery Place: Department of Health – Pharmaceutical Division, Philippine Blood Center, Quezon Avenue, Quezon City

5. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
6. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
