



## INVITATION TO BID

### PROCUREMENT OF ONE (1) LOT VARIOUS COMMUNICATION EQUIPMENT FOR THE BUREAU OF FIRE PROTECTION (BFP)

**Bid Reference No.: GPG-B1-2019-012**

1. The **Philippine International Trading Corporation (PITC)** and the **Bureau of Fire Protection (BFP)** intend to apply the sum of Pesos: One Hundred Twenty Two Million Two Hundred Seventy Thousand Five Hundred Sixty Nine and 62/100 (₱ 122,270,569.62) being the Approved Budget for the Contract (ABC) to payment under the contract for the Procurement of One (1) Lot Various Communication Equipment for the Bureau of Fire Protection (BFP). Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

2. PITC and BFP now invite bids from eligible and authorized Philippine Supplier/Dealer/Distributor of Communication Equipment and/or Systems Integrator for the Procurement of One (1) Lot Various Communication Equipment for the Bureau of Fire Protection (BFP). (hereafter referred to as GOODS).

3. Project Duration : within One Hundred Eighty (180) calendar days from receipt of Notice to Proceed.

Delivery Place : **For Item No. 1 (BFP-NCR)** : Bureau of Fire Protection National Headquarters (BFP – NHQ), Agham Road, Sitio San Roque, Brgy. Bagong Pag-asa, Quezon City.

**For item No. 2 (BFP-R3)** : Office of the Regional Director , BFP Region 3, Del Pilar, San Fernando City Pampanga

**Item No. 3 (HF Radio)** : Bureau of Fire Protection National Headquarters (BFP – NHQ), Agham Road, Sitio San Roque, Brgy. Bagong Pag-asa, Quezon City.

Installation Place : **Item No. 1 (BFP-NCR)** - See Section XI of Annex V-A1  
**Item No. 2 (BFP R3)** - See Section XI of Annex V-A2

4. A prospective Bidder must have completed a Single contract of similar nature within last **five (5) years** amounting to at least fifty percent (50%) of the ABC of the item being bid.

**“Similar” contract shall refer to contracts pertaining to the Supply, Delivery and Installation of Communication Equipment.**

5. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

6. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

7. Interested bidders may obtain further information from PITC and inspect the Bidding Documents at the address given below during office hours.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
