This **Supplemental/Bid Bulletin No. 2** is being issued in response to the concerns of the prospective bidder – Distinctive Blinds & Office Systems, Inc. in its letter addressed to the Chair dated 10 February 2019.

Query 1	Since part of the work involves Re-Configuration of Existing Modular Workstations, will it be acceptable if a bidder will mock-up One (1) Modular Partition to show the compatibility of its components with the existing modular workstations? Reason: Once the components are compatible with existing partitions, the rest of the modular partitions will follow the lay-out in the floor plan adopting the same looks, color and panel combination including the size of the perforation. The critical part in this bidding is COMPONENT COMPATIBILITY ISSUE with existing modular partition.
REPLY	As indicated in the Post Qualification Procedure of the Terms of Reference (TOR), the Lowest Calculated Bidder (LCB) shall install mocked-up models of the workstations at the designated place to be identified by the CLIENT, together with the samples of chairs and mobile drawer, for inspection, measurement and validation of the inter-operability and durability and other related works to ensure the technical compliance of the items to be procured. Failure to comply with this shall be a ground for disqualification of the LCB and will proceed with the post qualification of the next lowest bidder. Also, as agreed during the Pre Bid Conference bidders shall conduct site inspection to determine the compatibility and inter-operability of the modular partition to the existing units.
Query 2	As we had joined the 1 st bidding and it had failed, do we assume we do not have the pay for the bidding documents this rebidding?
REPLY	Request granted.

This Supplemental Bid Bulletin No. 2 shall form part of the Bidding Documents. Any provisions in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.
