The **Philippine International Trading Corporation (PITC)** and the **Department of Environment and Natural Resources – Environmental Management Bureau (DENR-EMB)** intend to apply the sum of **Pesos: Thirty Four Million Seven Hundred Eighty Three Thousand Seven Hundred Twenty Three only (₱ 34,783,723.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the Supply, Delivery, Installation, Testing and Commissioning of Solid Waste Management Equipment consisting of Ten (10) Sets Brand New Plastic Moulder for the Department of Environment and Natural Resources – Environmental Management Bureau (DENR-EMB).

Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. The PITC and DENR-EMB now invite Bids from authorized Philippine Fabricators/Manufacturers/Distributors for the Supply, Delivery, Installation, Testing and Commissioning of Solid Waste Management Equipment consisting of 10 Sets Brand New Plastic Moulder for the Department of Environment and Natural Resources – Environmental Management Bureau (DENR-EMB) (hereinafter referred to as **GOODS**).
3. The bidding is open to Filipino citizens / sole proprietorships, partnerships, or corporations under the laws of the Philippines and at least sixty percent (60%) interest or outstanding capital stock belong to citizens of the Philippines.
4. A prospective Bidder should have completed a contract of similar nature within the **last five (5) years** from the date of submission and receipt of bids amounting to at least **fifty percent (50%)** of the ABC.

**Similar contract** shall mean “**Industrial Equipment**”.

5. **Project Completion /Delivery, Installation, Testing and Commissioning** shall be within **One Hundred Twenty (120)** calendar days after receipt of Notice to Proceed or Opening of Letter of Credit whichever comes later.

Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
8. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
