The **Philippine International Trading Corporation (PITC)** and the **Philippine Coast Guard (PCG)** intend to apply the sum of Pesos: **One Million Five Hundred Ninety Nine Thousand Five Hundred & 00/100 Only (₱ 1,599,500.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **Supply and Delivery of Brand New Caterpillar Electronic Technician (ET) Diagnostic Laptop for the Philippine Coast Guard (PCG)**.

Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. The **PITC** and **PCG** now invite bids from authorized Philippine Suppliers, Dealers or Resellers for Brand New Caterpillar Electronic Technician (ET) Diagnostic Laptop for the Philippine Coast Guard (PCG) (hereinafter referred to as GOODS).
3. A prospective Bidder must have completed a single largest contract of similar nature within last **five (5) years** amounting to at least **fifty percent (50%)** of the ABC of the item being bid.

“Similar contract” shall mean **Marine Equipment**.

4. **Delivery Period:** Within Sixty (60) calendar days after receipt of Notice to Proceed.

Delivery Place: Coast Guard Surface Support Force, Pier 13, Port Area, Manila

5. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its **2016** Revised IRR.

6. The Invitation to Bid and Bidding Documents may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and PITC website at www.pitc.gov.ph. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
7. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am – 4:00pm) but not later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
