- 3. **Delivery/Completion Period**: Within **Ninety (90)** calendar days from the date of receipt of Notice to Proceed (NTP).
  - **Delivery/Installation Place**: Room 203, Electrical and Electronics Engineering (EEE) Institute, University of the Philippines Diliman, Quezon City
- PITC and CHED-PCARI now invites Bids from duly authorized manufacturers, dealers, distributors or resellers for the Supply, Delivery, Installation and Testing of One (1) Lot Brand New Laser Cutter Cartridge and Peripherals for the Commission on Higher Education Philippines-California Advanced Research Institute (CHED-PCARI). (hereafter referred to as GOODS).
- 5. The bidding is open to Philippine Suppliers, Dealers or Reseller for the Supply and Delivery of Off-the-Shelf AABR Test Equipment for CHED-PCAR.

6. A prospective Bidder should have completed a single contract of similar nature equivalent within the **last five (5) years** from the date of submission and receipt of bids amounting to at least **fifty percent (50%)** of the ABC.

"Similar contract" shall mean Laboratory Equipment.

- 7. Negotiation procedure will be conducted using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this negotiation including Eligibility Checking, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its 2016 Revised IRR.
