1. The **Philippine International Trading Corporation (PITC)** and the **University of the Philippines Manila –Philippine General Hospital (UPM-PGH)** intend to apply the sum of Pesos: **Twelve Million & 00/100 Only (₱12,000,000.00)** being the Approved Budget for the Contract (ABC) to payment for the **SUPPLY, DELIVERY, TESTING AND COMMISSIONING OF ONE (1) UNIT 2D ECHOCARDIOGRAM MACHINE WITH PHASE ARRAY PROBES, TEE AND CURVED ARRAY PROBE FOR THE UNIVERSITY OF THE PHILIPPINES MANILA - PHILIPPINE GENERAL HOSPITAL (UPM-PGH).**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PITC and UPM-PGH now invite Bids from Suppliers who are themselves Manufacturers or Local First Tier Distributors of the principal manufacturer of One (1) unit 2D Echocardiogram Machine with Phase Array Probes, Tee and Curved Array Probe for the University of the Philippines (Manila) - Philippine General Hospital (UPM-PGH) (hereinafter referred to as GOODS).

“First Tier Distributor” shall mean a Philippine registered company directly appointed by the principal manufacturer of the equipment with ongoing business relationship over the last five (5) years, regardless of the type of equipment/products carried for the principal manufacturer.

3. A prospective bidder should have a Single Largest Completed Contract similar to the contract to be bid within the last five (5) years from the date of submission and receipt of bids amounting to at least fifty percent (50%) of the ABC of the item/lot being bid.

*“Similar nature” shall mean **Echocardiogram Equipment**.*

4. The **Delivery / Completion Period**: Within **One Hundred Twenty (120)** calendar days from receipt of Notice to Proceed (NTP).
5. **Delivery Place**: Property Section, Philippine General Hospital, Taft Avenue, Manila
6. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
7. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am – 4:00pm) but not later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of the PhilGEPs and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
