PITC and CHED-PCARI now invite bids from authorized Philippine Suppliers, Dealers or Reseller for the Supply, Delivery and Installation of Two (2) Units Electrochemical Workstation + EIS and One (1) Unit High End Modular Potentiostat with EQCM, Dual-Mode Bipotentiostat and Ph Meter Modules for The Commission on Higher Education Philippines-California Agdvanced Research Institutes (CHED-PCARI).
- 3. A prospective Bidder must have completed a Single contract of similar nature within last five (5) years amounting to at least fifty percent (50%) of the ABC of the item being bid.

Similar contract shall mean "Laboratory Equipment".

4. The Delivery of GOODS shall be within One Hundred Twenty (120) calendar days upon receipt of Notice to Proceed (NTP).

Open competitive bidding procedures will be conducted using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its 2016 Revised IRR.
