- 3. The PITC and DSWD-FO1 now invite Bids from Philippine Suppliers / Distributors for the Supply and Delivery of One (1) Lot Various Non-Food Relief Commodities (hereinafter referred to as **GOODS**).
- 4. The bidding is open to Filipino citizens / sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging citizens of the Philippines.
- 5. A prospective Bidder should have completed a contract of similar nature within the **last five (5)** years from the date of submission and receipt of bids amounting to at least **fifty percent (50%)** of the ABC.

Similar contract shall mean "General Merchandise".

- 6. Delivery Period: Within thirty (30) calendar days upon receipt of Notice to Proceed Delivery Place: DSWD-FO1 Quezon Avenue, City of San Fernando, La Union
- 7. Open competitive bidding procedures will be conducted using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic

- Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
