1. The **Philippine International Trading Corporation (PITC)** and the **Vicente Sotto Memorial Medical Center (VSMMC)** intend to apply the sum of the following being the Approved Budget for the Contract (ABC) to payment under the contract for the Supply, Delivery, Installation and Testing of One (1) Lot Brand New Neurosurgery Craniotome and One (1) Unit Brand New Neurosurgical Microscope for Vicente Sotto Memorial Medical Center (VSMMC).

2. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
3. The PITC and VSMMC now invite Bids from Authorized Philippine Suppliers, Dealers, or Resellers for the Supply, Delivery, Installation and Testing of One (1) Lot Brand New Neurosurgery Craniotome and One (1) Unit Brand New Neurosurgical Microscope (hereinafter referred to as **GOODS**).
4. The bidding is restricted to Filipino citizens / sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging citizens of the Philippines.
5. A prospective Bidder should have completed a contract of similar nature within the **last five (5) years** from the date of submission and receipt of bids amounting to at least **fifty percent (50%)** of the ABC.

Similar contract shall mean “**Operating Room Equipment**”.

6. Delivery Period: Within sixty (60) calendar days after receipt of Notice to Proceed
Delivery Place: Property Section, Vicente Sotto Memorial Medical Center, B. Rodriguez St., Cebu City
7. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
8. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.
- It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
