WHEREAS, in response to the aforementioned postings, only The Pharmedic Corporation (Botica de Santa Cruz) (hereinafter "Pharmedic") purchased bidding documents for Lot No. 2;

WHEREAS, during the scheduled submission and opening of bids on 29 October 2019, Pharmedic submitted its Eligibility and Technical Documents and its Financial Bid for the subject item;

**WHEREAS**, on the date of submission and opening of bids, this Committee proceeded to open the Eligibility and Technical documents of **Pharmedic** and declared **Pharmedic's** eligibility and technical submittals as **"Passed"**;

**WHEREAS**, having passed the eligibility and technical checking, this Committee proceeded to open the financial bid of **Pharmedic**, the result of which is as follows:

**WHEREAS**, pursuant to the Post-Qualification procedures under the 2016 Revised IRR of RA 9184 and after careful examination, validation and verification of the eligibility, technical and financial requirements on post-qualification, the bid submitted by **THE PHARMEDIC CORPORATION (BOTICA DE SANTA CRUZ)** was found to be the **SINGLE CALCULATED AND RESPONSIVE BID** for **Lot No. 2**, as shown by the corresponding **Notice of Post Qualification**, a copy of which is hereto attached as **Annex "B"** and made an integral part hereof;
