



## INVITATION TO BID

PITC and VSMMC now invite bids from authorized Philippine Suppliers, Dealers or Reseller for the SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF ONE (1) UNIT BRAND NEW FIBROSCAN TOUCH AND ONE (1) UNIT BRAND NEW DUODENOSCOPE VIDEO SYSTEM FOR VICENTE SOTTO MEMORIAL MEDICAL CENTER (VSMMC)
3. A prospective Bidder should have completed a contract of similar nature within the last five (5) years from the date of submission and receipt of bids as follows:  
Single completed contract of similar nature amounting to at least fifty percent (50%) of the ABC.  
*"Similar nature" shall mean **Medical Equipment**.*
4. The **Delivery / Completion Period**: Within **One Hundred Twenty (120)** calendar days from receipt of Notice to Proceed.

**Delivery Place**: Property Section, Vicente Sotto Memorial Medical Center, B. Rodriguez St. Cebu City

5. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.

6. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am – 4:00pm) but not later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
