



INVITATION TO BID

SUPPLY AND DELIVERY OF BRAND NEW PASSENGER VANS FOR THE BUREAU OF CUSTOMS (BOC)

1. The **Philippine International Trading Corporation (PITC)** and the **Bureau of Customs (BOC)** intend to apply the sum of the following amounts being the Approved Budget for the Contract (ABC) to payments under the contract for each lot below ;

- Surety bond *callable upon demand equivalent to at least 5% of the ABC

* Only those issued and confirmed by a Local Universal or Local Commercial Bank

** Must be callable upon demand issued by a Surety or Insurance Company duly certified by the Insurance Commission as authorized to issue such bond

*** SEPARATE BID SECURITY PER LOT

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. **PITC** and **BOC** now invite bids from authorized Philippine Automotive Dealers/ Suppliers/Distributors for the Supply and Delivery of Brand New Passenger Vans (hereafter referred to as GOODS).
3. A prospective Bidder should have completed a contract of similar nature within the **last five (5) years** from the date of submission and receipt of bids amounting to at least **fifty percent (50%)** of the ABC.
"Similar contract" shall mean **Motor Vehicle**.
4. The Brand of the Passenger Van being offered must have been in the Philippine Market for the last **fifteen (15) years**.

5. **Delivery Period and Delivery Place:**

Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016 Revised IRR**.
7. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

Note: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.

It may be also downloaded free of charge from the website of the **PhilGEPS** and the **PITC** website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents.
