PITC and CHED-PCARI now invite bids from authorized Philippine Suppliers, Dealers or Reseller for the SUPPLY AND DELIVERY OF FIVE (5) UNITS POWER LOGGING RECORDER FOR THE ELECTRICAL AND ELECTRONICS ENGINEERING INSTITUTE OF THE UNIVERSITY OF THE PHILIPPINES FOR THE COMMISSION ON HIGHER EDUCATION - PHILIPPINES-CALIFORNIA ADVANCED RESEARCH INSTITUTES (CHED-PCARI).
3. A prospective Bidder must have completed a Single contract of similar nature within last five (5) years amounting to at least fifty percent (50%) of the ABC of the item being bid.
Similar contract shall mean “ Electrical Testing Equipment”.
4. Delivery Period : within Sixty (60) calendar days after receipt of Notice to Proceed.
Delivery Place : Electrical and Electronics Engineering Institute, Velasquez St., UP Campus, Diliman, Quezon City

5. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
6. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
