	<p>Supply and Installation of underground facilities (4" Main Pipe HDPE with three (3) 32 mm Subducts inside)</p> <p>*** May we request for your approval to use 1-run 50mm HDPE pipe for supply and installation of underground facilities using Horizontal Direction Drilling (HDD)?</p> <p>Reasons:</p> <ol style="list-style-type: none"> 1. Suggested 50mm HDPE SDR11 pipe (250mtrs per roll) can also accommodate 2-3 Fiber Optic Cable for future expansion 2. 4" HDPE pipe is too expensive 3. 4" HDPE pipe maximum length 40mtrs only per roll. (will require multiple butt welding) 4. Subduct 32mm 3-runs might not fit in the 4" HDPE Pipe 5. HDPE pipe butt welding might affect the inside diameter of the pipe 6. HDPE pipe welding will slowdown installation process (need to cool down the welded area) <p>Hoping for your understanding and consideration, please.</p>
