The **Philippine International Trading Corporation (PITC)** and the **Philippine Coast Guard (PCG)** intend to apply the sum of Pesos: **Six Million Seven Hundred Fifty Five Thousand One Hundred Eighty & 00/100 Only (₱ 6,755,180.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **Supply and Delivery of One (1) Lot Brand New Tertiary LED Lanterns and Solar Wires for the Philippine Coast Guard (PCG)**.

2. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
3. The PITC and PCG now invite bids from authorized Philippine Suppliers, Dealers or Resellers of Brand New Tertiary LED Lanterns for the Philippine Coast Guard (PCG) (hereinafter referred to as GOODS).
4. The PITC and PCG now invite Bids from Suppliers who are themselves Manufacturers or First Tier Distributors of the principal manufacturer of **Brand New Tertiary LED Lanterns for the Philippine Coast Guard (PCG)** (hereinafter referred to as GOODS).

"First Tier Distributor" shall mean a Philippine-based company directly appointed by the principal manufacturer of the equipment regardless of the type of equipment/products carried for the principal manufacturer.

However, Foreign Manufacturers must be represented by a Philippine based Company.

5. **Delivery Period:** Within Ninety (90) calendar days after receipt of Notice to Proceed.

Delivery Place: MSSC Cavite Buoy Base, Sangley Point, Cavite City.

6. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its **2016** Revised IRR.
7. The Invitation to Bid and Bidding Documents may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and PITC website at www.pitc.gov.ph. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
8. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am – 4:00pm) but not later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
