The **Philippine International Trading Corporation (PITC)** and the **Bureau of Customs** intend to apply the sum **PESOS: Fifty Four Million and 00/100 (P54,000,000.00)** being the Approved Budget for the Contract (ABC) to payment for the **Supply and Delivery of Brand New Passenger Vans – Manual Transmission for Bureau of Customs (BOC)**.

2. Financial Proposals received in excess of the ABC shall automatically be rejected. The Bids and Awards Committee have the option to negotiate on the Financial Proposal received that is within the ABC.
3. **PITC** and **BOC** now invite bids from authorized Philippine Automotive Dealers/Suppliers/Distributors for the Supply and Delivery of Brand New Passenger Vans (hereafter referred to as GOODS).
4. A prospective Bidder should have completed a contract of similar nature within the **last five (5) years** from the date of submission and receipt of bids amounting to at least **fifty percent (50%)** of the ABC.
“Similar contract” shall mean **Motor Vehicle**.
5. The Brand of the Passenger Van being offered must have been in the Philippine Market for the last **fifteen (15) years**.

7. The bidding is restricted to Filipino citizens / sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging citizens of the Philippines.
8. A prospective Bidder must have completed a single largest contract of similar nature within last **five (5) years** amounting to at least **fifty percent (50%)** of the ABC of the Motor Vehicle Similar contract shall mean “**Motor Vehicle**”.
9. Negotiation procedure will be conducted using a non-discretionary “pass/fail” criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this negotiation including Eligibility Checking, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its 2016 Revised IRR.
10. The Invitation for Negotiation and Negotiation Documents may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and PITC website at www.pitc.gov.ph.
