Query No. 1	(page 81 of the BDS) May we request to relax minimum managed AP for the Access Controller from 150 to 128?
Reply No. 1	Request Denied. The minimum APs that can be managed by the controller is 150. It is based on the devices that we are familiar and tested with.
Query No. 2	(ITB 12.1 vi of the BDS) For the SLCC – (Configuration of Wireless Network Equipment). Would you accept Installation of Microwave Radio equipment or is it specific to access point only?
Reply No. 2	If it's a Wireless Network Equipment with relation to internet connectivity. It is acceptable.

Where will the remaining 2 units of 10G MMD transceiver module be connected? Will it also have a transceiver module ready?
Reply No. 1	We intend to use the 2 transceivers to connect the TWC Core switch to the TESDA core switch through a backbone switch of TESDA located at the TWC. As shown in the diagram in the Terms of Reference (TOR). There are no ready modules, it only has provision to accept transceiver modules.
Query No. 2	Annex V-A Page 80 - Terms of Reference - Item 5 Where will the outdoor access point be mounted? (Wall or Ceiling)
Reply No. 2	The outdoor AP will be mounted in one of the columns of TWC located at the lobby. It will be wall mounted.
Query No. 3	Sec. VII Page 84 - Additional Requirements for Bidders May we request to add in the category for proposed brand must be in Gartner - Leaders Quadrant? This to ensure that the device is enterprise class and not for small business? Also, to ensure that the vendors are on the same level of proposal.
