



INVITATION TO BID

SUPPLY AND DELIVERY OF 246 UNITS BRAND NEW CALIBER 9MM PISTOL FOR THE PHILIPPINE COAST GUARD (PCG)

1. The **Philippine International Trading Corporation (PITC)** and the **Philippine Coast Guard (PCG)** intend to apply the sum of the following being the Approved Budget for the Contract (ABC) to payment under the contract below:

2. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
3. **PITC** and **PCG** now invite bids from authorized Philippine Manufacturers or First Tier Distributors for the Supply and Delivery of 246 Units Brand New Caliber 9mm Pistol for the Philippine Coast Guard (PCG) (hereafter referred to as GOODS).

“First Tier Distributor” shall mean a Philippine-based company directly appointed by the principal manufacturer of the item who has been engaged in the sale of firearms for a cumulative period of five (5) years and with a valid and current Indentor’s License to deal in firearms, ammunition, spare parts and accessories for sale to the Law Enforcement Agencies and Other Authorized Government Agencies.

4. **Delivery Place:** National Headquarters PCG, Port Area Manila
Delivery Period: Within **one hundred fifty (150) calendar days** after Receipt of Notice to Proceed.
5. A prospective Bidder must have completed a single largest contract of similar nature within the last **five (5) years** amounting to at least **fifty percent (50%)** of the ABC of the lot being bid.

“Similar contract” shall mean **Firearms**.

6. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its **2016** Revised IRR.

7. The bidding is open to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
8. The Invitation to Bid and Bidding Documents may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and PITC website at www.pitc.gov.ph. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
9. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am – 4:00pm) but not later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

However, bidders who previously bought bidding documents for Bid Reference No. GPG-B1-2019-220 may acquire the bidding documents free of charge upon presentation of official receipt.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
