SUPPLY AND DELIVERY OF 25 UNITS BRAND NEW TRACTORS (120HP) FOR THE SUGAR REGULATORY ADMINISTRATION (SRA)

1. The **Philippine International Trading Corporation (PITC)** and the **Sugar Regulatory Administration (SRA)** intend to apply the sum of Pesos: Seventy Three Million Seven Hundred Fifty Thousand Pesos & 00/100 (**₱73,750,000.00**) being the Approved Budget for the Contract (ABC) to payment for the Supply and Delivery of 25 units Brand New Tractors (120HP) for the Sugar Regulatory Administration (SRA).

2. Bids received in excess of the ABC for the project shall be automatically rejected at Bid opening.
3. PITC and SRA now invite bids from manufacturers or authorized local distributors, dealers, resellers for the Supply and Delivery 25 units Brand New Tractors (hereafter referred to as GOODS).
4. **Project Completion Period and Deployment Sites:**

Note: Project Completion Period shall include visual inspection and actual field testing prior to delivery at the deployment sites.

5. A prospective Bidder should have completed within the last five (5) years from the date of submission and receipt of bids equivalent to:
 - One (1) single contract of similar nature amounting to at least fifty percent (50%) of the ABC of the project; OR
 - Two (2) or more contracts of similar nature equivalent to at least fifty percent (50%) of the ABC for the project the largest of these contracts must be equivalent to at least twenty five percent (25%) of the ABC of the project.

“Similar” contract shall refer to contracts pertaining to farm machineries with horsepower rating of 30 and above.
6. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
