PITC and DENR-EMB now invite bids from authorized Philippine Fabricators/Manufacturers/Distributors of Industrial Equipment for the Supply, Delivery, Installation, Testing and Commissioning of Solid Waste Management Equipment Consisting of Five (5) Lots of Brand-New Set of Plastic Recycling Equipment with Brand New Plastic Chair Molds for the Department of Environment and Natural Resources – Environmental Management Bureau (DENR-EMB) (hereafter referred to as GOODS).

5. A prospective Bidder must have completed a Single contract of similar nature within last five (5) years amounting to at least fifty percent (50%) of the ABC of the lot being bid.

**Similar contract shall mean “Industrial Equipment”.**

6. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
