



INVITATION TO BID

CONSTRUCTION OF THREE (3) STOREY BUILDING WITH BASEMENT OF THE BUREAU OF CUSTOMS-SUB PORT OF PUERTO PRINCESA, PALAWAN Bid Ref. No. GPG-B2-2018-189

Approved Budget for the Contract (ABC): **₱48,113,933.80**

1. The **Philippine International Trading Corporation (PITC)** and the **Bureau of Customs (BOC)**, intend to apply the sum of Pesos: Forty Eight Million One Hundred Thirteen Thousand Nine Hundred Thirty Three and 80/100 (₱48,113,933.80), being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction of Three (3) Storey Building with Basement of the Bureau of Customs-Sub Port of Puerto Princesa, Palawan**, more particularly described as follows:

***The Cashier's/Manager's Check must be issued by a Local Universal or Local Commercial Bank**

2. Bids received in excess of the ABC shall be automatically rejected at bid opening. Late Bids shall not be accepted.
3. PITC and BOC now invites Contractors with valid and current Philippine Contractors Accreditation Board (PCAB) License with Classification/Category in General Building/Specialty Work and with **Minimum License Category of B** and **Minimum Size Range of Medium A**, to bid for the **Construction of Three (3) Storey Building with Basement of the Bureau of Customs-Sub Port of Puerto Princesa, Palawan** (hereinafter referred to as the "WORKS"). The PCAB license must indicate "PCAB registered contractor for Government Projects."
4. Completion Period for the Construction of Three (3) Storey Building with Basement of the Bureau of Customs-Sub Port of Puerto Princesa, Palawan is within **Two Hundred Forty (240) calendar days** from Day One (1) indicated in the Notice of Site Possession.

Project Site: Block No. 7 Lot No. 1-B, Government Center and Natures Park
Brgy Sta. Monica, Puerto Princesa City, Palawan

5. Prospective Bidders should have completed a single contract similar to the project, equivalent to at least fifty percent (50%) of the ABC adjusted to current prices using the National Statistics Office consumer price index to be supported by the following.
 - a) Constructor's Certificate of Performance Evaluation System (CPES) Rating Sheet which must have at least a Satisfactory Rating; or
 - b) Owner's Certificate of Acceptance or
 - c) Owner's Certificate of Completion

For purposes of this project, similar contracts shall refer to contracts involving construction of buildings or vertical structures.

6. Open competitive bidding will be conducted using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (2016 Revised IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act." All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and



Post Qualification procedures and Award of Contract shall be governed by R.A. 9184 and its 2016 Revised IRR.

7. Bidding is open to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
8. The Invitation to Bid and Bidding Documents may be downloaded free of charge from the website of the **Philippine Government Electronic Procurement System (PhilGEPS) and PITC Website** at www.pitc.gov.ph. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours from 8:00 AM to 4:00 PM on weekdays only.
9. The complete set of bidding documents may be acquired/purchased by interested bidders during office hours (8:00AM-4:00PM) but no later than 4:00PM upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of PhilGEPS and PITC, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the bid documents.
