QUERY 1	We would like to clarify the statement from the Minutes of the Meeting for the project “Construction of UP New Clark City – Phase 1 for the University of the Philippines”, page 3 of the said minutes states that for the Terms of Reference (Annex IV-A), Bidders to fill out the conform portion on all pages. The attached Terms of Reference in the bidding documents has no conform portion. Can we ask for a copy of revised Terms of Reference?
REPLY 1	The Terms of Reference attached is for reference only. There is no need to put conforme/signature on each page. Please refer to the Amended Minutes of the Meeting.
QUERY 2	Another question, in case of discrepancy between the given plans and terms of reference, which will prevail?
REPLY 2	<p>The Plans and Terms of Reference are complementary to each other. Plans are particularly suited to show where the materials are located. Thus, plans exist essentially to show dimension, location and placement. Not all works, however, can be presented in the drawings. Generalized works are usually in statement form and hence, the contractor is required to read the Terms of Reference carefully.</p> <p>The Terms of Reference is used to describe the materials, construction techniques, samples, shop drawings, guarantees and other contract requirements. Together, the drawings and the Terms of Reference are used to provide the bidder with the needed information to complete their bid proposal.</p>

This **Supplemental/Bid Bulletin No. 2** shall form part of the Bidding Documents. Any provision in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.
