Query 01	<p>“We would like to inform your good office that there are two (2) items which we cannot comply based on the Terms of Reference (TOR) for we could not located suppliers that can provide them. They are as follows;</p> <p>1) Type of Asphalt to be used for the courts; and</p> <p>2)Tennis Court with two (2) star ITF rating</p> <p>Please confirm if we would really need to provide these two (2) based on the TOR.”</p>
REPLY	<p>1) The Terms of Reference (TOR) is provided as a guide to prospective bidders and shall be construed as supplemental to the Plans, and Specifications ; in order for them to come up with their bid proposal.</p> <p>The prospective bidder can propose materials for tennis courts asphalt pavement layer in compliance with ITF standards subject to the approval of the Office of Design and Planning Initiatives (ODPI)- University of the Philippines – Diliman (UP-DILIMAN).</p> <p>2) We are advising prospective bidder to review ITF Technical Booklet 2019 Part B: ITF Guide to Test Methods for Tennis Court Surfaces as reference in the construction methodology and requirements of the project.</p> <p>The University shall cover all cost of ITF accreditation and certification for two (2) star ITF rating. This requirement shall not be part of the contract between the winning bidder and the Philippine International Trading Corporation (PITC) because it is not included in the Bill of Quantities (BOQ). However, the winning bidder shall ensure that the courts are ready for ITF accreditation and certification.</p>

This **Supplemental/Bid Bulletin 2** shall form part of the Bidding Documents. Any provisions in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.
