Query 1:	We are much interested to participate in the bidding, but as of today, we have no "similar contract (carpentry tools) awarded to us equivalent to at least fifty percent (50%) of the total ABC", but we are positive that we can submit a competitive bid for the supply and delivery of said carpentry tools.
