

## **INVITATION TO BID**

# SUPPLY AND DELIVERY OF 15,000 PACKS OF MEAL, READY-TO-EAT (MRE) FOR THE GENERAL HEADQUARTERS, ARMED FORCES OF THE PHILIPPINES (GHQ, AFP)

1. The Philippine International Trading Corporation (PITC) and the General Headquarters, Armed Forces of the Philippines (GHQ, AFP) intend to apply the sum of the following being the Approved Budget for the Contract (ABC) to payment under the contract for each lot below:

- Bidders may bid for one or both lots provided all units per lot are supplied and must be of the same brand/model.
- Separate Bid Security for each lot being bid

Bids received in excess of the ABC shall be automatically rejected at Bid opening.

- 2. PITC and GHQ, AFP now invite Bids from Local Food Manufacturers for the Supply and Delivery of 15,000 packs of Meal, Ready-to-Eat (MRE) for the General Headquarters, Armed Forces of the Philippines (GHQ, AFP) (hereafter referred to as GOODS).
- 3. The bidding is open to Filipino citizen/sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging to citizen of the Philippines.

# 4. Delivery period:

One Hundred Twenty (120) calendar days after receipt of Notice to Proceed (NTP)

### **Delivery Place:**

Supply Unit (Provisional), GHQ & HSC, Camp General Emilio Aguinaldo, Quezon City

- 5. A prospective Bidder must have a single completed contract of similar nature within the last five (5) years amounting to at least twenty five percent (25%) of the ABC of the item being bid
  - "Similar" contract shall mean Food Items.
- 6. Open competitive bidding procedures will be conducted using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its 2016 Revised IRR.

- 7. The Invitation to Bid and Bidding Documents may be downloaded from the website of the **Philippine**Government Electronic Procurement System (PhilGEPS) and PITC website at <a href="https://www.pitc.gov.ph">www.pitc.gov.ph</a>. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am 4:00pm) on weekdays only.
- 8. The complete set of bidding documents maybe acquired by interested bidders during office hours (8:00am 4:00pm) but no later than 4:00pm upon payment of a non-refundable fee as indicated above. The bidding documents shall be received personally by the prospective bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the bid documents.
