

## **INVITATION TO BID**

## OVERHAULING OF THREE (3) UNITS DAMPER ASSEMBLY WITH PART NUMBER PN: 109-0112-38-103 OF THE MAIN ROTOR OF AW109E HELICOPTER (NH430) FOR THE PHILIPPINE NAVY (PN)

1. The Philippine International Trading Corporation (PITC) and the Philippine Navy (PN) intend to apply the sum of PESOS: One Million Nine Hundred Seventy One Thousand and 00/100 only (P 1,971,000.00) VAT Inclusive being the Approved Budget for the Contract (ABC) to payment under the contract for the Overhauling of Three (3) Units Damper Assembly with Part Number PN: 109-0112-38-103 of the Main Rotor of AW109E Helicopter (NH430) for the Philippine Navy (PN) more particularly described as follows:

- 2. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
- 3. PITC and PN now invite Bids from local OEM authorized repair / overhaul facility for the Overhauling of Three (3) Units Damper Assembly with Part Number PN: 109-0112-38-103 of the Main Rotor of AW109E Helicopter (NH430) for the Philippine Navy (PN) (hereafter referred to as GOODS).
- 4. **Project Completion Period**: Within one hundred twenty (120) calendar days after receipt of Notice to Proceed.
- 5. **Delivery Site**: Headquarters Naval Air Group, Naval Base Heracleo Alano, Sangley Point, Cavite City
- 6. A prospective Bidder should have completed **one (1) single contract** similar to the contract to be bid amounting to at least fifty percent (50%) of the ABC of the project **within the last five (5) years** from the date of submission and receipt of bids.

<sup>&</sup>quot;Similar contract" shall mean Repair and Maintenance of AW109 Aircraft.



- 7. Open competitive bidding procedures will be conducted using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its **2016** Revised IRR.
- 8. The Invitation to Bid and Bidding Documents may be downloaded from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and **PITC website** at <u>www.pitc.gov.ph</u>. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am 4:00pm) on weekdays only.
- 9. The complete set of Bidding Documents may be acquired/purchased by interested bidders during office hours (8:00am 4:00pm) but no later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.
  - It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
