



INVITATION TO BID

1. The **Philippine International Trading Corporation (PITC)** and the **Philippine Navy (PN)** intend to apply the sum of **PESOS: Six Million Nine Hundred Twenty Eight Thousand Nine Hundred Twenty & 75/100 only (₱ 6,928,920.75) (Inclusive of VAT)** being the **Approved Budget for the Contract (ABC)** to payment under the contract for the **REPAIRS OF LCU ROK 78 FOR THE PHILIPPINE NAVY (PN) – ONE (1) LOT**.

2. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
3. **PITC and PN** now invite Bids from MARINA Licensed Ship Builders or Ship Repairers for the **REPAIRS OF LCU ROK 78 FOR THE PHILIPPINE NAVY (PN)** (hereafter referred to as GOODS).
4. The bidding is open to Filipino citizens / sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging citizens of the Philippines.
5. Project Completion Period: Within Forty Five (45) calendar days from receipt of Notice to Proceed.
- Project Site: Naval Shipyard, Naval Sea Systems Command, Naval Station Pascual Ledesma, Cavite City
- The final acceptance and turn-over of the vessel shall be at the Naval Shipyard, Naval Sea Systems Command, Naval Station Pascual Ledesma, Cavite City.
6. A prospective Bidder should have completed **within the last five (5) years** from the date of submission and receipt of bids **at least one (1) single contract** similar to the contract to be bid amounting to at least **fifty percent (50%)** of the ABC of the item being bid for.

“Similar Contract” shall mean Repair of Steel Hull Vessel.



7. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its **2016** Revised IRR.
8. The Invitation to Bid and Bidding Documents may be downloaded from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and **PITC website** at www.pitc.gov.ph. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
9. The complete set of Bidding Documents maybe acquired by interested bidders during office hours (8:00am – 4:00pm) but no later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

However, bidders who previously bought Bidding Documents under Bid Ref. No. MPG-BI-2018-318, may acquire Bidding Documents free of charge upon presentation of the Official Receipt.

For the Pre-bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the Bidding Documents.
