

## INVITATION TO BID

### SUPPLY AND DELIVERY OF 46 UNITS DRESSING, 31 UNITS BRAND NEW PULSE OXIMETER, 30 UNITS BRAND NEW AUTOMATED EXTERNAL DEFIBRILLATOR AND 25 UNITS BRAND NEW LARYNGOSCOPE FOR THE PHILIPPINE ARMY (PA)

1. The **Philippine International Trading Corporation (PITC)** and the **Philippine Army (PA)** intend to apply the following sums being the Approved Budget for the Contract (ABC) to payment under the contract for each item.

2. **PITC and PA** now invite Bids from authorized dealers, distributors or resellers for the **Supply and Delivery of 46 units Dressing, 31 units Brand New Pulse Oximeter, 30 units Brand New Automated External Defibrillator and 25 units Brand New Laryngoscope for the Philippine Army (PA)** (hereafter referred to as GOODS).
3. The bidding is open to Filipino citizen/sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging to citizen of the Philippines.

- A prospective Bidder must have completed a Single contract of similar nature within last five (5) years amounting to at least fifty percent (50%) of the ABC of the item being bid.

Similar contract shall mean “Medical Equipment”.

- Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its **2016** Revised IRR.
- The Invitation to Bid and Bidding Documents may be downloaded from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and **PITC website at [www.pitc.gov.ph](http://www.pitc.gov.ph)**. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
- The complete set of Bidding Documents maybe acquired by interested bidders during office hours (8:00am – 4:00pm) but no later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
