This **Supplemental Bid Bulletin No. 3** is being issued to respond to the request of Megaship Builders, Inc. per letter dated May 14, 2019 and received on the same day:

We would like to respectfully request for a 2 week postponement of the opening of bids for the Supply and Delivery of Sixteen (16) units Brand New Fiberglass Reinforced Plastic Watercraft (Speedboat) for the Philippine Navy. (PN)

The requirement for the foreign manufacturer's certification is being processed by the various manufacturer's and we were informed that such military supplies certifications have to go through the process that will take about 2 weeks to obtain.

In light of the foregoing, we pray that our request for the 2 week postponement to ensure that we can supply the best product at the best price for the Philippine Government will be approved.

Response of PN dated 14 May 2019

Request denied. The request of Megaship Builders, Incorporated for the extension of two (2) weeks for the Submission and Opening of Proposed Negotiation of Bids for the PN Speedboat Project will delay the process of its procurement which is already long overdue. This kind of request from prospective bidder/s impedes the progress of the project implementation.
