



**INVITATION TO BID**

**SUPPLY AND DELIVERY OF BRAND NEW 35 PCS. RUN FLAT INSERT, CMDO V150 SFV AND 50 PCS. ROAD WHEELS FOR APC/AIFV OF THE PHILIPPINE ARMY (PA)**

1. The **Philippine International Trading Corporation (PITC)** and the **Philippine Army (PA)** intend to apply the sums being the Approved Budget for the Contract (ABCs) (Inclusive of VAT) to payment under the contract for each item more particularly described as follows:

2. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
3. **PITC and PA** now invite Bids from authorized suppliers, distributors, dealer or reseller for the **Supply and Delivery of Brand New 35 pcs. Run Flat Insert, CMDO V150 SFV and 50 pcs. Road Wheels for APC/AIFV** of the Philippine Army (PA) (hereafter referred to as GOODS).
4. The bidding is open to Filipino citizen/sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

**5. Required Delivery Period and Delivery Place shall be as follows:**

6. The Bidder must have completed a **single contract** similar to the contract to be bid amounting to at least **twenty five percent (25%)** of the ABC of the project **within the last five (5) years** from the date of submission and receipt of bids

Item No. 1: "Similar contract" shall mean **Pneumatic Vehicle Tire**.

Item No. 2: "Similar contract" shall mean **Spare Parts for Armored Vehicle**.

7. Open competitive bidding procedures will be conducted using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its **2016** Revised IRR.



8. The Invitation to Bid and Bidding Documents may be downloaded from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and **PITC website** at [www.pitc.gov.ph](http://www.pitc.gov.ph). Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
9. The complete set of Bidding Documents may be acquired/purchased by interested bidders during office hours (8:00am – 4:00pm) but no later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

**Note:** For item procurement, the maximum fee for the Bidding Documents for each item shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all items shall not exceed the maximum fee prescribed in the guidelines for the sum of the ABC of all items.

Bidding Documents may be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
