SUPPLY AND DELIVERY OF 19,045 SETS BRAND NEW AFP ONE BDU WITH CAP FOR THE PHILIPPINE AIR FORCE (PAF)

1. The **Philippine International Trading Corporation (PITC)** and the **Philippine Air Force (PAF)** intend to apply the sum of **PESOS: Thirty Six Million Seven Hundred Thirteen Thousand Two Hundred Thirty-Six and 95/100 (₱ 36,713,236.95) (VAT Inclusive)** being the **Approved Budget for the Contract (ABC)** to payment under the contract for the **Supply and Delivery of 19,045 Sets Brand New AFP One BDU with Cap for the Philippine Air Force (PAF)** more particularly described as follows:

2. **PITC and PAF** now invite Bids from eligible **Local Manufacturers** for the **Supply and Delivery of 19,045 sets Brand New AFP One BDU with Cap for the Philippine Air Force (PAF)** (hereafter referred to as **GOODS**).
3. **Required Delivery period: Full Delivery within Ninety (90) calendar days** from receipt of Notice to Proceed, in accordance with the following schedule:

4. A prospective Bidder should have completed within the last five (5) years from the date of submission and receipt of bids a single contract similar in nature amounting to at least twenty five percent (25%) of the ABC.

“Similar” contract shall mean sewn items.

5. **Open competitive bidding procedures will** be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its **2016** Revised IRR.
6. The Invitation to Bid and Bidding Documents may be downloaded from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and **PITC website** at **www.pitc.gov.ph**. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
7. The complete set of bidding documents may be acquired by interested bidders during office hours (8:00am – 4:00pm) but no later than 4:00pm upon payment of a non-refundable fee as indicated above. The bidding documents shall be received personally by the prospective bidder or his duly authorized representative upon presentation of proper identification document.

Bidding Documents may be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

However, bidders who previously bought Bidding Documents under Bid Ref. Nos. MPG-BI-2019-046 may acquire Bidding Documents free of charge upon presentation of the Official Receipt for said previous project.

For the Pre-bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the bid documents.
