The attached Annex V-A3 for Test Criteria indicated that an acceptance test from two (2) sampling will be done. We hereby request for clarification whether all three tranches will undergo acceptance test.
<b>Response 1</b>	<b>Yes, random sampling will be conducted for every delivery. Therefore, all three (3) tranches will undergo Test and Acceptance Procedures as described in Annex V-3.</b>
